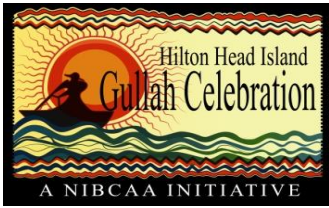
Please review the following points to help us make sure the exhibition runs smoothly and is a success for all:

- Please submit your application and bio sheet with picture (1 page limit).
- Each artist is limited to a maximum of 5 original pieces of artwork. All artwork is limited to a maximum size of 36 by 40 inches. There may be opportunities to submit additional artwork if pieces are sold.
- Bin art is limited to a maximum of 50 individual items. There will be opportunity to refill items when others are sold.
- There will be an Opening Reception on Thursday, January 30th from 5:00 - 9:00p.m. All Artists are encouraged to attend.
- The last date of the show is Saturday, February 29th. Artwork must be picked up by Sunday, March 1st between 10am and 2pm, at The Art Center of Coastal Carolina. Any remaining artwork will be taken to the NIBCCA office at 539 William Hilton Parkway, HHI, SC 29926. Please pick up any remaining artwork by March 4th. Office hours are from 10am until 4pm.
- Mandatory compliances for participation by all Artist are listed below:
 1. All Artwork must be labeled with Your Name, Title of the Art, and Price with a card on the front and back.
 2. All Artwork must be original and not shown previously at the De Arts Ob We People Exhibition.
 3. Artwork must be ready for hanging, ex: wiring attached, hanging hooks.
 4. No photos, prints and giclee's will be hung on walls.
 5. All art must be secured with gallery wrap.
 6. No art will be accepted after 5pm on Thursday January 23, 2020.

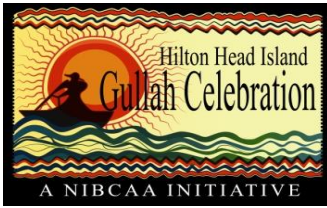
